Code of Conduct in the L2P Program

1. Purpose

This Code of Conduct outlines the responsibilities of Learner Drivers participating in the Learner Driver Mentor Program (L2P). By signing this document, you agree to uphold the program's policies and procedures, fostering a safe and respectful learning environment. Breaches of this agreement may result in dismissal from the program.

2. Learner Responsibilities

As a Learner Driver in the L2P Program, I commit to:

- Following all L2P policies and procedures, including adherence to road laws and regulations.
- Prioritizing the safety and well-being of myself, my Mentor, and other road users.
- Treating everyone with respect, regardless of gender, ability, cultural background, or faith.
- Accepting full responsibility for any fines incurred while driving a program vehicle.
- Attending all scheduled meetings and driving sessions punctually.
- Providing at least 24 hours' notice if I need to cancel a professional driving lesson.
- Understanding that failure to attend two sessions without notice may result in removal from the program.
- Being honest, reliable, and consistent in my participation.
- Maintaining regular communication with the Program Coordinator regarding my progress and logbook.
- Reporting any concerns or difficulties with my Mentor or the program to the L2P Program Coordinator.
- Notifying the L2P Program Coordinator of any changes to my contact details promptly.

3. Learner Licence Conditions

During my participation, I understand and agree to the following learner licence requirements:

- Always being accompanied by a supervisory driver while driving.
- Holding my learner licence for a minimum of 12 continuous months.
- Completing 80 logbook hours, including at least 15 hours of night driving.
- Not towing vehicles, including trailers.
- Driving no faster than 90 km/h, regardless of the posted speed limit.
- Clearly displaying L plates on the vehicle.
- Refraining from using mobile phones, including hands-free or speaker functions, while driving.
- Maintaining a zero Blood Alcohol Concentration (BAC) and being free of drugs while driving.

4. Health & Safety Compliance

To ensure safety and effective participation, I will:

- Respond promptly to calls or messages from my Mentor and Program Coordinator.
- Listen to my Mentor and comply if they request that I stop driving for safety reasons.
- Keep discussions with my Mentor confidential, except when safety concerns arise.

5. Behavioural Expectations

To maintain professionalism and respect in the program, I agree to:

- Maintaining a professional relationship with my Mentor and treating them respectfully.
- Avoiding personal relationships with my Mentor or their family members.
- Not exchanging home addresses or meeting my Mentor outside official L2P sessions.
- Understanding that if I gain access to a private supervising driver, my participation in the L2P Program may be reviewed to provide opportunities for other Learners.
